## Resolution No. 2012-24

RESOLUTION OF THE NASSAU COUNTY INDUSTRIAL DEVELOPMENT AGENCY (THE "AGENCY") APPROVING THE SPONSORSHIP OF THE BARCLAYS PGA TOUR PLAYOFF EVENT

WHEREAS, the Nassau County Industrial Development Agency (the "Agency") is authorized and empowered by the provisions of Chapter 1030 of the 1969 Laws of New York, constituting Title I of Article 18-A of the General Municipal Law, Chapter 24 of the Consolidated Laws of New York, as amended (the "Enabling Act"), and Chapter 674 of the 1975 Laws of New York, as amended, constituting Section 922 of said General Municipal Law (said Chapter and the Enabling Act being hereinafter collectively referred to as the "Act") to, inter alia, promote the economic welfare, recreation opportunities and prosperity of the inhabitants of New York State and to actively promote, develop, encourage and assist in the promotion, attraction and development of economically sound commerce and industry to advance the job opportunities, health, general prosperity and economic welfare of the people of the State of New York, to improve their economic welfare, recreation opportunities, prosperity and standard of living, and to prevent unemployment and economic deterioration, and to promote the development of facilities to provide recreation for the citizens of New York State and to attract tourists from other states; and

WHEREAS, PGA Tour, Inc., as operator of the PGA Tour, develops and runs certain professional golf tournaments for purposes of, among other things, encouraging tourism, including, without limitation, the 2012 Barclays PGA Tour Playoff event (the "Event"); and

WHEREAS, the purposes of such Event are consistent with the mission of the Agency; and

WHEREAS, the Agency desires to support the Event to encourage tourism and promote economic development in Nassau County;

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NASSAU COUNTY INDUSTRIAL DEVELOPMENT AGENCY, AS FOLLOWS:

Section 1. The Agency hereby approves the financial support by the Agency of the Event more particularly set forth in a certain form of Hospitality Purchase Agreement between the Agency and PGA Tour, Inc. (the "Agreement"), at a cost that is anticipated not to exceed \$22,500 plus any applicable taxes. The Agency finds that the Event contemplated by the Agreement is unique and that therefore no competitive bidding process is feasible.

Section 2. The Executive Director is hereby authorized and directed, in his sole discretion, to negotiate and enter into the Agreement in the form presented by PGA Tour, Inc., 421207.1

together with such changes to the terms and conditions thereof that the Executive Director may deem advisable or necessary, subject to the terms of this Resolution. The Executive Director's execution of the Agreement shall evidence the Agency's approval of the terms thereof.

Section 3. This Resolution shall take effect immediately.
