RESOLUTION OF THE NASSAU COUNTY INDUSTRIAL DEVELOPMENT AGENCY AUTHORIZING THE EXECUTIVE DIRECTOR TO ENGAGE CAMOIN ASSOCIATES TO PROVIDE CERTAIN ECONOMIC DEVELOPMENT CONSULTING SERVICES

WHEREAS, the Nassau County Industrial Development Agency (the "Agency") is authorized and empowered by the provisions of Chapter 1030 of the 1969 Laws of New York, constituting Title I of Article 18-A of the General Municipal Law, Chapter 24 of the Consolidated Laws of New York, as amended (the "Enabling Act"), and Chapter 674 of the 1975 Laws of New York, as amended, constituting Section 922 of said General Municipal Law (said Chapter and the Enabling Act being hereinafter collectively referred to as the "Act") to promote, develop, encourage and assist in the acquiring, constructing, reconstructing, improving, maintaining, equipping and furnishing of manufacturing, industrial and commercial facilities, among others, for the purpose of promoting, attracting and developing economically sound commerce and industry to advance the job opportunities, health, general prosperity and economic welfare of the people of the State of New York, to improve their prosperity and standard of living, and to prevent unemployment and economic deterioration; and

WHEREAS, the Agency may from time to time require the services of qualified firms ("Firms") to perform certain economic development consulting services, including, without limitation, the development of cost/benefit analyses with respect to the Agency's "projects" (collectively, "Projects"); and

WHEREAS, the Agency issued a Request for Proposals to Provide Certain Professional Economic Development Consulting Services (the "RFP") seeking proposals from interested Firms, and the Agency published notice of the issuance of such RFP on June 28, 2010 in *Newsday*; and

WHEREAS, the Agency received a proposal (the "Proposal") from Camoin Associates expressing interest in providing the services contemplated by the RFP (collectively, the "Services"); and

WHEREAS, in accordance with its Charter, the Finance Committee of the Agency reviewed the Proposal, determined that further interviews of Camoin Associates would not be necessary or desirable, found that Camoin Associates meets the minimum requirements set forth in the RFP and is qualified to provide the Services, and recommended that the Agency engage Camoin Associates to provide the Services; and

WHEREAS, the Agency desires to engage Camoin Associates to provide the Services;

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NASSAU COUNTY INDUSTRIAL DEVELOPMENT AGENCY, AS FOLLOWS:

Section 1. The Agency hereby ratifies and confirms all actions heretofore taken by the Agency's staff and the Finance Committee in connection the procurement of the Services pursuant to the RFP.

Section 2. The Agency hereby determines that the procurement of the Services pursuant to the RFP constitutes a procurement of services for the benefit of a third party and for which payment will be made from funds provided by such third party or a person or entity other than the Agency and, therefore, is not subject to the requirements of the Agency's Statement of Procurement Policy and Procedures.

Section 3. The Agency hereby determines that the proposed action is a Type II Action pursuant to Article 8 of the New York Environmental Conservation Law (including the regulations thereunder, "SEQRA") involving "continuing agency administration" which does not involve "new programs or major reordering of priorities that may affect the environment" (6 NYCRR §617.5(c)(20)) and therefore no Findings or determination of significance are required under SEQRA.

Section 4. The Agency hereby accepts the recommendations of the Finance Committee (i) that further interviews of Camoin Associates not be required, (ii) that Camoin Associates is found to meet the minimum requirements set forth in the RFP and is qualified to provide the Services, and (iii) that the Agency engage Camoin Associates to provide the Services.

Section 5. The Executive Director is hereby authorized and directed to negotiate and enter into one (1) or more retainer agreements or similar contracts with Camoin Associates, if deemed advisable or necessary by the Executive Director, on such terms and subject to such conditions as the Executive Director may deem advisable or necessary, subject to the terms of this Resolution and the requirements of the RFP; provided, however, that the cost of obtaining the Services for a Project shall be borne solely by the Project applicant or other third party person or entity. The Executive Director's execution of any such agreement or contract shall evidence the Agency's approval of the terms thereof.

Section 6. This Resolution shall not preclude the Agency from appointing and engaging other consultants as determined from time to time by the members of the Agency.

Section 7. This Resolution shall take effect immediately.
