RESOLUTION FINDING THAT ACTION TO UNDERTAKE A  
CERTAIN PROJECT FOR L.S. 130 SUNRISE REALTY, LLC WILL NOT HAVE A  
SIGNIFICANT ADVERSE IMPACT ON THE ENVIRONMENT

WHEREAS, the Nassau County Industrial Development Agency (the "Agency") is authorized and empowered by the provisions of Chapter 1030 of the 1969 Laws of New York, constituting Title I of Article 18-A of the General Municipal Law, Chapter 24 of the Consolidated Laws of New York, as amended (the "Enabling Act"), and Chapter 674 of the 1975 Laws of New York, as amended, constituting Section 922 of said General Municipal Law (said Chapter and the Enabling Act being hereinafter collectively referred to as the "Act") to promote, develop, encourage and assist in the acquiring, constructing, reconstructing, improving, maintaining, equipping and furnishing of manufacturing, industrial and commercial facilities, among others, for the purpose of promoting, attracting and developing economically sound commerce and industry to advance the job opportunities, health, general prosperity and economic welfare of the people of the State of New York, to improve their prosperity and standard of living, and to prevent unemployment and economic deterioration; and

WHEREAS, to accomplish its stated purposes, the Agency is authorized and empowered under the Act to acquire, construct, reconstruct and install one or more "projects" (as defined in the Act) or to cause said projects to be acquired, constructed, reconstructed and installed and to convey said projects or to lease said projects with the obligation to purchase; and

WHEREAS, L.S. 130 SUNRISE REALTY, LLC, a limited liability company organized and existing under the laws of the State of New York (the "Applicant"), presented an application (the "Application") to the Agency, which Application requested that the Agency consider undertaking a project (the "Project") consisting of the following: (A)(1) the acquisition of an interest in a certain parcel of land located at 130 Sunrise Highway, Incorporated Village of Valley Stream, Town of Hempstead, Nassau County, New York (Section: 39; Block: 7; Lots: 485-492) (the "130 Sunrise Parcel"), (2) the renovation and expansion of the existing buildings (collectively, the "130 Sunrise Building") on the 130 Sunrise Parcel, together with related improvements to the 130 Sunrise Parcel, and (3) the acquisition of certain furniture, fixtures, machinery and equipment (the "130 Sunrise Equipment") necessary for the completion thereof (collectively, the "130 Sunrise Project Facility"); (B)(1) the acquisition of an interest in a certain

parcel of land located at 148 Sunrise Highway, Incorporated Village of Valley Stream, Town of Hempstead, Nassau County, New York (Section: 39; Block: 7; Lots: 458-463) (the "148 Sunrise Parcel"), (2) the renovation and expansion of the existing building (collectively, the "148 Sunrise Building") on the 148 Sunrise Parcel, together with related improvements to the 148 Sunrise Parcel, and (3) the acquisition of certain furniture, fixtures, machinery and equipment (the "148 Sunrise Equipment") necessary for the completion thereof (collectively, the "148 Sunrise Project Facility"); (C)(1) the acquisition of an interest in a certain parcel of land located at 164 Sunrise Highway, Incorporated Village of Valley Stream, Town of Hempstead, Nassau County, New York (Section: 39; Block: 7; Lots: 58 and 59) (the "164 Sunrise Parcel" and together with the 130 Sunrise Parcel and the 148 Sunrise Parcel, collectively, the "Land"), (2) the renovation and expansion of the existing buildings (collectively, the "164 Sunrise Building" and together with the 130 Sunrise Building and the 148 Sunrise Building, collectively, the "Building") on the 164 Sunrise Parcel, together with related improvements to the 164 Sunrise Parcel, and (3) the acquisition of certain furniture, fixtures, machinery and equipment (the "164 Sunrise Equipment" and together with the 130 Sunrise Equipment and the 148 Sunrise Equipment, collectively, the "Equipment") necessary for the completion thereof (collectively, the "164 Sunrise Project Facility" and together with the 130 Sunrise Project Facility and the 148 Sunrise Project Facility, collectively, the "Project Facility"), all of the foregoing for use by the Applicant and/or its affiliates as an automobile sales facility; (D) the granting of certain "financial assistance" (within the meaning of Section 854(14) of the General Municipal Law) with respect to the foregoing in the form of potential exemptions or partial exemptions from real property taxes and sales and use taxes (collectively, the "Financial Assistance"); (E) the lease (with an obligation to purchase), license or sale of the Project Facility to the Applicant or such other entity as may be designated by the Applicant and agreed upon by the Agency; and (F) the sublease thereof to the Applicant or such other entity(ies) as may be designated by the Applicant and agreed upon by the Agency; and

WHEREAS, pursuant to Article 8 of the New York Environmental Conservation Law, Chapter 43-B of the Consolidated Laws of New York, as amended (the "SEQR Act") and the regulations adopted pursuant thereto by the Department of Environmental Conservation of the State of New York, being 6 NYCRR Part 617, et. seq., as amended (the "Regulations" and collectively with the SEQR Act, "SEQRA"), the Agency must satisfy the requirements contained in SEQRA prior to making a final determination whether to undertake the Project; and

WHEREAS, pursuant to SEQRA, to aid the Agency in determining whether the Project may have a significant adverse impact upon the environment, the Applicant submitted to the Agency: (1) Part 1 of the Full Environmental Assessment Form dated March 24, 2015 (the "EAF"), (2) Applicant's Application for Financial Assistance dated August 7, 2014, and (3) Real Property Assessment Analysis dated February 10, 2015 (collectively the "Project Environmental Documents"); and

WHEREAS, pursuant to SEQRA, the Agency desires to conduct a review of the Project to determine whether the Project may have a significant adverse impact on the environment and whether an Environmental Impact Statement must be prepared with respect to the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NASSAU COUNTY INDUSTRIAL DEVELOPMENT AGENCY AS FOLLOWS:

Section 1. Based upon a thorough review and examination of the Project Environmental Documents and upon the Agency's knowledge of the area surrounding the Land and such further investigation of the Project and its environmental effects as the Agency has deemed appropriate, the Agency makes the following findings with respect to the Project:

(A) The Agency is undertaking an uncoordinated review of the proposed action in accordance with the requirements of SEQRA;

(B) Prior to making a recommendation about the potential environmental significance of the Project, the Agency has consulted several information sources, and has considered the list of activities which are Type I Actions outlined in Section 617.4 of the Regulations, the list of activities that are Type II Actions outlined in Section 617.5 of the Regulations, and the criteria for determining significance outlined in Section 617.7 of the Regulations; and

(C) The Project is an Unlisted action pursuant to SEQRA as it involves the renovation and expansion of the Building on two existing commercial sites, and one vacant site. The new portion of the construction is minor and consists of the expansion of the existing 164 Sunrise Building onto the 148 Sunrise Parcel. The 148 Sunrise Building and 164 Sunrise Building will be one 16,125 square foot two-story building used to house a new Honda car sales facility. The 130 Sunrise Building will house a used Honda car sales facility. Less than an acre of land will be disturbed, well below the threshold of 10 acres for a Type 1 action, and less than 500 parking spots will be added, the expansion threshold for a Type 1 action.

Section 2. No potentially adverse significant impacts on the environment are noted in the EAF and none are known to the Agency.

Section 3. Based upon the foregoing investigations of the potential environmental impacts of the Project and considering both the magnitude and importance of each environmental impact indicated, the Agency makes the following determinations with respect to the Project.

The Project will not have a significant adverse impact upon the environment. The reasons supporting this determination are as follows:

1. Impact on Land. The Project consists of the interior renovation of the 130 Sunrise Building and the renovation, expansion and construction of the 164 Sunrise Building and 148 Sunrise Building for use as a new and used

Honda car dealership. The 130 Sunrise Building and 164 Sunrise Building are previously existing commercial/retail facilities. The zoning and land use classification will not change as a result of the Project. The Project is consistent with the Commercial zoning classification of the Land and is consistent with the surrounding uses, composed of commercial and retail uses. The construction of a portion of the Building will develop currently vacant land, and there are residential uses in the vicinity of the area, however the Land is located on a commercial strip and the Building will be similar to existing and neighboring uses in the area. The Project is not anticipated to create any potentially significant adverse impacts to land resources or land use.

2. Impact on Water. The Land does not contain, nor lie in the immediate vicinity of any surface water body. There are no wetlands on site. Though the Project will create some additional impervious surfaces, less than an acre of land will be disturbed, and the increase in impervious surfaces is minor. As such, no adverse impacts to water are anticipated.
3. Impact on Air. The Project will not be a significant source of air emissions. The Project will not entail the types of activities or operations that are associated with a potential for air emissions. The Project will not result in a significant increase in traffic, as the Building was previously used for commercial/retail use. The existing roadway system has the capacity to accommodate additional traffic volumes and a minor increase in traffic would not be a significant impact to air quality. Impacts to air from construction activity will not be significant and are temporary. The Project will not create any significant adverse impacts to air resources.
4. Impact on Plants and Animals. Although some impacts to flora and fauna may potentially occur with the portion of construction of the Building on land not currently developed, the Land in the area of the Project does not possess significant ecological value as it is within a developed commercial area. The Project will not create significant adverse impacts to animals, plants or natural communities, wildlife habitat or wetlands.
5. Impact on Agricultural Land Resources. The Project is located in an area currently used for commercial purposes. The Project will not involve the conversion or loss of agricultural land resources and no impacts to agricultural land resources are anticipated.
6. Impact on Aesthetic Resources. The Land is in a developed commercial area with no scenic views known to be important to the community. Lighting in the parking lot will be directed downward and shielded from neighboring properties. No significant adverse impacts to aesthetic resources are anticipated.



7. Impact on Historic and Archeological Resources. The Project does not contain, nor is it adjacent to any historically significant resources or archeologically sensitive areas. Areas near the Land were previously developed and lack the characteristics that would suggest the potential presence of significant archaeological resources. The Project is not anticipated to create any potentially significant adverse impacts to historical or archaeological resources.
8. Impact on Open Space and Recreation. The Land is commercial in nature and does not comprise public open space and is not used for recreation. The Land is over two miles from Valley Stream State Park. No significant impacts to open space or recreational resources are anticipated.
9. Impact on Critical Environmental Areas. The Project Site is not located in or substantially contiguous to any Critical Environmental Area ("CEA"). There will be no significant adverse impacts to any CEA.
10. Impact on Transportation. The Project will not result in a substantial increase in traffic above present levels or generate substantial new demand for transportation facilities or services. The Project will not create any significant adverse impacts related to transportation resources.
11. Impact on Energy. Though the portion of new construction of the Building will result in an increase in energy usage, the increase is not significant, existing utility lines serve the Land and no significant improvements are necessary to accommodate the Project.
12. Impact on Noise and Odor. Operation of the Project is not expected to appreciably increase ambient noise levels or to create odors. The proposed Project, which consists of the renovation, expansion and construction of a used and new car sales facility, does not involve the types of activities that create significant noise or odors. No service or collision repair will be performed on the Land. Any impacts to noise and odor from construction activities will be minor and temporary. Thus, the Project will not create any significant adverse impacts to noise or odors.
13. Impact on Public Health. The Project does not entail the types of activities or operations that are associated with a significant potential for affecting public health, such as storing large amounts of hazardous or toxic materials. No historical spills have been reported on the Land. As such, the Project is not anticipated to create a significant adverse impact to public health.
14. Impact on Growth and Character of the Community and Neighborhood. The Project will not result in population growth and is in character with

adjacent development. The Project will not create any significant adverse impacts to the growth or character of the community.

15. Considering all of the above, the Project will not have a significant adverse impact upon the environment and a negative declaration pursuant to SEQRA is hereby issued.

Section 4. The Chairman, Administrative Director and Executive Director of the Agency are each hereby authorized and directed to distribute copies of this Resolution to the Applicant and to do such further things or perform such acts as may be necessary or convenient to implement the provisions of this Resolution.

Section 5. This Resolution shall take effect immediately.


