RESOLUTION OF THE NASSAU COUNTY INDUSTRIAL DEVELOPMENT AGENCY (THE "AGENCY") APPOINTING AN ADMINISTRATIVE ASSISTANT

WHEREAS, the Nassau County Industrial Development Agency (the "Agency") is authorized and empowered by the provisions of Chapter 1030 of the 1969 Laws of New York, constituting Title I of Article 18-A of the General Municipal Law, Chapter 24 of the Consolidated Laws of New York, as amended (the "Enabling Act"), and Chapter 674 of the 1975 Laws of New York, as amended, constituting Section 922 of said general Municipal Law (said Chapter and the Enabling Act being hereinafter collectively referred to as the "Act") to, inter alia, promote the economic welfare, recreation opportunities and prosperity of the inhabitants of New York State and to actively promote, develop, encourage and assist in the promotion, attraction and development of economically sound commerce and industry to advance the job opportunities, health, general prosperity and economic welfare of the people of the State of New York, to improve their economic welfare, recreation opportunities, prosperity and standard of living, and to prevent unemployment and economic deterioration, and to promote the development of facilities to provide recreation for the citizens of New York State and to attract tourists from other states; and

WHEREAS, the Agency has from time to time, by resolution of the members of the Agency, appointed persons to serve in various capacities for the Agency, to execute its activities and operations; and

WHEREAS, the Agency at times has needed, and it currently needs, an administrative assistant to handle various office duties and to assist the officers and other staff of the Agency in fulfilling various tasks, as needed, for the Agency; and

WHEREAS, the Agency wishes to appoint Nicole Gil, to serve it in that capacity; and

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE NASSAU COUNTY INDUSTRIAL DEVELOPMENT AGENCY, AS FOLLOWS:

Section 1. Having determined that Nicole Gil has the experience and qualifications required for the position, the Agency appoints as of the date hereof Nicole Gil as an administrative assistance for the Agency. The Chair of the Agency is hereby authorized to negotiate the compensation and other terms of the employment relationship with Nicole Gil, on behalf of the Agency but subject to the Agency's approved budget.

Section 2. This Resolution shall not preclude the Agency from appointing person to any other officer of or position with the Agency, as determined from time to time by the members of the Agency.

Section 3. The Agency hereby determines that the proposed action is a Type II Action pursuant to Article 8 of the New York Environmental Conservation Law (including the regulations thereunder, "SEQRA") involving "continuing agency administration" which does not involve "new programs or major reordering of priorities that may affect the environment" (6 NYCRR

Section 6.17.5 (c)(26)) and therefore no Findings or determination of significance are required under SEQRA.

Section 4. This Resolution shall take effect immediately.


